Terms and Conditions:

The Rolling Stock Fund will be used to:

- acquire suitable rolling stock to run a heritage railway service.
- cover any transportation expenses to move the items of rolling stock to the railway,
- cover any reasonable administrative expenses incurred with the purchase and transportation of the rolling stock, for example transportation insurance, or temporary storage costs incurred.
- purchase additional items of rolling stock if funds permit.
- fund the restoration of any rolling stock acquired. (However the PWRS reserves the right to launch separate funding appeals for this purpose)

The Poulton and Wyre Railway Society may:

- on behalf of the Rolling Stock Fund, take out loans to assist with the purchase, transportation and restoration of rolling stock.
- continue to operate the Rolling Stock Fund in the future in order to fund the purchase of additional items of rolling stock.

In the event of the Society being wound up, any Rolling Stock acquired will be disposed of in accordance with the Society's Constitution concerning asset disposal.

Ownership.

- Any rolling stock purchased will remain the property of the Poulton & Wyre Railway Society.
- Any donation made will not buy a share in any rolling stock.
